Installation

Introduction

This User Reference Guide covers basic installation and setup of the 5800 Series Business Class Routers including:

- 5851 Symmetric Digital Subscriber Line router (SDSL)
- 5861 Asymmetric DSL / Discrete Multi Tone router (DMT)
- 5865 Asymmetric DSL / DMT (international) router
- 5871 Integrated Services Digital Network DSL router (IDSL)

Installation Requirements

- CD-ROM Drive
- Ethernet network interface card
- TCP/IP network protocol installed
- Web browser
- Terminal emulation software if you want to configure your router via your computer's serial port before placing it into service on a network.

Connecting Your Router

- 1. Place your router in a location where it will be well ventilated. Do not stack it with other devices or place it on carpet.
- 2. Connect your PC directly to any of the router's four Ethernet ports, using one of the red straight-through cables. You may also connect one to seven additional Ethernet devices to the router's built-in Ethernet hub.
- 3. Connect your router to the DSL jack using the remaining Ethernet 10Base-T, RJ-45 cable.
- 4. Connect the router to an AC power outlet using the power cord.

To reduce the risk of fire, use only no. 26 AWG or smaller guage telecommunication cord to connect the DSL port on your router a DSL telephone jack.

Configuring Your Computer

- 1. Configure the TCP/IP protocol stack on your computer to obtain an address automatically from the router. To do so with a PC running Windows 9x or NT, select **Start** > **Settings** > **Control Panel** > and click on **Network**.
- 2. Select the **Configuration** tab at the top of the dialog. Users with Windows NT select the **Protocols** tab.
- 3. From the list of network components, select TCP/IP.
- 4. Click on the **Properties** button.
- 5. Select the **IP** Address tab.
- 6. Ensure that "Obtain an IP Address Automatically" is selected. Users of Windows NT should select "Obtain an IP Address from a DHCP server".
- 7. Click **OK** as needed to confirm your settings, and reboot your computer.

Chapter 2

Easy Setup

Router Information Screen

The first screen in the Web User Interface is the Router Configuration screen. This screen displays basic router information and router configuration settings. It also provides links to other router setup and control forms. On the Router Configuration screen, the following information is presented:

- **Router Information** Including the model number, software version number and options that have been enabled.
- **Router Configuration** Displays router configuration details such as LAN IP address, WAN data and voice PVC (ATM) or DCLI (frame relay), WAN protocol and WAN network settings.

A menu of links is on the left side of the Router Configuration screen. This menu links to forms that provide settings for your router. Easy Setup is the first set of forms on the menu.

Click on the Easy Setup link to begin a basic configuration of your router.

The first Easy Setup screen is for entering and reviewing information about Wide Area Network (WAN) settings. Your Network Service Provider (NSP) can provide you with the information needed to correctly make these WAN settings. Your Network Service Provider should specify a WAN protocol, and VPI/VCI settings for you to use.

- 1. Enter the WAN interface VPI/VCI numbers in the fields provided.
- Your router supports any one of five available WAN protocols: PPP, RFC 1483, RFC 1483 MER (for ATM), and RFC 1490 or RFC 1490 MER for frame relay. To make your selection, click on the button shown next to the appropriate protocol.
- 3. Click on the **Next** button to continue Easy Setup.

- 1. If you have selected PPP as your WAN protocol, you will see a screen requesting a PPP User Name and a PPP Password. Enter this information in the fields provided.
- 2. Select one of the following PPP Networking options:
 - **Bridging** will forward all traffic for remote hosts that is not routed (non-IP) to the WAN.
 - **IP Routing** will route all IP packets for remote hosts to the WAN.
 - Network Address Translation (NAT) allows multiple workstations on your LAN to share a single, public IP address. All outgoing traffic appears to originate from the router's IP address.
 - NetBIOS is a PC networking protocol that can keep network connections open inadvertently. To avoid excess connection charges, such traffic should be blocked on any metered network service.

Chapter 3

Additional Features

Beyond Easy Setup, your router is equipped with additional features that add services and value to your DSL connection. These features can be implemented using the Web interface links found on the Router Information Screen. These features, along with brief descriptions of each, are listed below:

- Access Control The Access Control feature restricts administrative access and control of your router to a select group of hosts.
- **Feature Activation** This feature supports the installation of feature activation keys that are used to enable additional features on your router.
- **Current Date and Time** This feature enables you to set the date and time on your router.
- Set DHCP The DHCP feature enables or disables DHCP, and manages your IP address pool.
- **Set NAT** This feature enables or disables Network Address Translation between the Local and Wide Area Networks.
- Set Firewall A simple yet powerful network security feature for the creation and development of firewalls.
- **Dial Backup** The Dial Backup feature provides a backup connection to the Internet through an external modem, connected to the console port of your router.
- **IKE/IPSec Configuration** This is an optional feature for your router. IKE/IPsec (Internet Key Exchange/Internet Protocol Security) configuration screens enable optional authentication and encryption of IP traffic for the authenticity, integrity and privacy of your communications.
- **Command Line Interface** The Command Line Interface (CLI) is used for advanced router configuration.

Several optional software features are available for your router, such as L2TP, IPSec, DES Encryption, and 3DES Encryption. These features can be purchased from the Efficient Networks web site (www.efficient.com). You will need your router serial number to purchase a feature activation key. For each optional feature purchased, you will be emailed a feature activation key.

Feature activation keys are used to enable additional features on your router. Features that are not activated on your router are marked with a dash (-) as shown on the screen to the right. Feature activation keys are long strings in the following format:

To input a feature activation key:

- 1. Copy the entire key, including the brackets, from the email.
- 2. Paste the key into the input box on this form.

This feature enables you to make and view the current Dynamic Host Configuration Protocol (DHCP) settings for your router. DHCP is a TCP/IP service protocol to provide dynamic leasing of IP addresses and other configuration information to client hosts on the network. Your router can perform as a DHCP server with central management of your IP address pool for simple and safe TCP/IP configuration and IP address conservation. When DHCP is combined with Network Address Translation (NAT), your router adds a measure of security to your network through the leasing and concealment of private IP addresses behind one unique public IP address. These private IP addresses also help avoid the costs associated with obtaining additional public IP addresses to support a growing network.

To activate DHCP, select **Enable** from the New Setting list and click on the **Apply** button. Conversely, selecting Disable will deactivate DHCP.

With DHCP, all IP addresses are assigned to network clients from a pool. The **IP Addresses Pool Setting** section provides fields for defining the range of IP addresses included in your pool. The fields under Current Setting display the current range of the IP Address pool. Use the fields under the New Setting label to define a new range of IP addresses for the pool. Click on the **Apply** button to establish the new IP addresses pool settings.

The **Current DHCP Leases List** shows the network clients that are currently leasing their IP addresses from the pool. From left to right, the following information is presented on each row:

- **Client IP:** Displays the leased IP address assigned to that specific client.
- State: Indicates whether the IP address is enabled or disabled.
- **Host Name:** Displays the name of the host leasing that specific IP address.
- **Expires (mm/dd/yy):** Displays the date when the IP address lease will expire. At that time (if not before), the leased IP address will be freed for re-assignment, and the network client will need to request a new IP address from the router.

After DHCP settings have been completed, click on the **Back to Home** button to return to the home screen.

Network Address Translation (NAT) is a feature that can provide a level of security by hiding the private IP addresses of your LAN behind the single public IP address of your router. All connections must come through your router and be translated by NAT. Network addresses on inbound traffic are translated from public to private IP addresses, while addresses on outbound traffic are translated

from private IP addresses to the router's public IP address, thereby concealing the private IP addresses used on your Local Area Network (LAN). Network Address Translation can provide a level of security by obscurity that is acceptable to many users.

Outbound NAT Setting: Use this field to enable or disable Network Address Translation of outbound traffic; communications from your LAN to the Wide Area Network beyond your router (WAN). Click on the **Apply** button to complete the new setting.

Inbound NAT Setting: This section of the form is divided into two parts. The left side contains fields for WAN settings. The right side contains fields for local machine settings. A section labeled "router" divides these two parts. This layout is a simple diagram of how NAT works between the WAN and the local machine to translate network addresses.

Two methods are available for making inbound NAT settings:

Easy Setup: You can quickly configure your inbound NAT to support the most common network services with the Easy Setup fields. Select a network service from the drop down list on the WAN side of the form, and then enter the IP address of the local machine on the local machine side of the form. Click on the **Add** button next to the label "Default Port#", unless you want to specify an alternate port to use for the selected service. If you want to specify an alternate port, use the field marked "Port#" to enter your alternate port, and press its **Add** button to complete the service setup for inbound NAT.

Advanced Setup: The Advanced Setup fields give you the option of assigning specific network protocols to specific ports on the WAN side of NAT, while mapping the WAN settings to an IP address and port number of a local machine.

- 1. Select the protocol from the drop down list.
- 2. Enter the first port number for the protocol in the **First Port**# field. If you want to assign a range of ports for the protocol, enter the last port number in the range in the **Last Port**# field.
- 3. In the Local Machine part of the Advanced Setup section, enter the IP address of the local machine in the **IP Address** field.
- 4. Enter the port number on the local machine for the protocol to use. Leave this field blank if you want the local machine to use the same port number as the WAN.
- 5. Press the **Add** button next to the Default Port# or the Port# field (as appropriate) to finish your advanced NAT configuration. Repeat this process for each protocol you want to configure for NAT.

Press the **Reboot** button to restart the router with the new NAT settings. Press **Back to Home** to cancel your NAT settings and return to the home screen.

Your router can secure your network and data communications with built-in firewall capabilities. A firewall is any combination of hardware and software that secures a network and traffic to prevent interception or intrusion. Your router is equipped with predefined scripts that can be modified or used directly to construct firewalls. You can select from four firewall options:

- **Maximum:** Establishes a firewall with the most restrictive policies for maximum network security.
- **Medium:** Establishes a firewall with flexible policies for a moderate level of network security.
- **Minimum:** Establishes a firewall with a basic set of policies for a minimum level of network security.
- None: No firewall.

Make your selection, and press the **Apply** button to implement your firewall. To cancel, press the **Back to Home** button and return to the home screen.

For many networks, these predefined firewalls will protect against all but the most sophisticated attacks. For the experienced network security technician, these predefined scripts can serve as a starting point for custom configurations to support your own unique network policies.

Dial Backup provides a backup connection to the Internet through an external V.90 modem, connected to the console port of your router. This backup connection can be activated in the event of a DSL service interruption. During a DSL interruption, your router will use the dialup modem connection while waiting for DSL service to be restored. Once the DSL link is active again, Dial Backup will automatically switch back to the DSL service. Voice service is disabled during dial backup.

A special console connector is required to configure Dial Backup. This connector can be ordered through your Internet Service Provider, or from the Efficient Networks web site at the following URL: http://www.efficient.com/

To access the Dial Backup screen, select the Dial Backup link from the Router Information screen. The Dial Backup screen will appear. To enable Dial Backup, follow these steps:

- 1. Enter your user name and password as provided from your ISP.
- 2. Enter at least one telephone number for dialup access to your ISP.
- 3. Click the **OK** button to continue with Dial Backup Configuration.
- 4. The next screen provides settings for Dial Backup Configuration:
 - -Failover after connection is lost: This setting specifies the time interval between losing the DSL connection and switching to the dialup modem connection.
 - -Resume DSL after connection is lost: The time interval between checks for service restoration is called the retry period. After each retry period, your router will test the DSL connection for service. If service is restored, the router will switch data traffic to the DSL connection. The serial port will revert to its default function as the console port.
 - -Serial Port Data Rate: This field specifies the maximum rate at which data can flow through the serial port. This setting should equal the maximum baud rate of the attached modem.
 - -Modem Initialization String: This field sets the initialization string used by the V.90 modem attached to the console port of the router.
 - -**Modem Dial String**: Sets the dial string for one of two possible dialing options; pulse or tone dialing. The default is tone dialing.

IKE/IPSec is an optional feature for your router. IKE/IPsec (Internet Key Exchange/Internet Protocol Security) configuration screens enable optional authentication and encryption of IP traffic for the authenticity, integrity and privacy of your communications. IPsec sessions are established through Security Associations (SAs) that enable secure devices to negotiate a level of security attributes needed for a Virtual Private Network (VPN).

The home screen for IKE/IPSec configuration displays current IKE and IPSec definitions. These definitions must be established by using the Easy IKE/IPSec Setup and Advanced IKE/IPSec Setup screens.

The Command Line Interface (CLI) is used for advanced router configuration. It can be accessed through a connection between your workstation and the console port of your router. Use a straight through (red label) cable and a DB9 adapter to connect your router to your PC serial port. Boot both systems and open a connection using your VT 100 terminal emulation program. Use the following port settings:

- Baud Rate: 9600
- Data bits: 8
- Parity: None
- Stop bits: 1
- Flow control:Hardware

Note: The console port is disabled if Dial Backup is enabled.

Chapter 4

Frequently Asked Questions

Which cable do I use to connect a new LAN device to the router?

If you are connecting your LAN device to one of the Ethernet ports on your router, use a straight-through (red) cable.

If you are connecting your router directly to another hub, then use a crossover (yellow) cable. If your hub has a built-in crossover or uplink port, then you must use a straight-through (red) cable.

Can I connect the router to a 100Base-T hub?

Yes, if the hub has a 10/100 switch. You need to set the switch to 10 for the router connection.

What is the router password?

The default user name is login and the password is admin.

We strongly recommend that you change the router password from the default to your own password. If your NSP has changed the router password from the default, you'll need to contact them for assistance.

What security options do I have?

Network Address Translation (NAT) is a feature that can provide a level of security by hiding the private IP addresses of your LAN behind the single public IP address of your router. All connections must come through your router and be translated by NAT.

Further security is available with IP filtering firewall software. The firewall can be accessed through the Web GUI or Command Line Interface (CLI) and configured with scripts for a "quick" firewall. A qualified technician should perform all firewall configuration. Efficient Networks cannot be liable for vulnerabilities arising from inadequate firewall configurations.

To provide secure connections across the Internet, consider purchasing the Virtual Private Network (VPN) software option. Additional information on NAT, Firewall, and Secure VPN can be found in the CLI Reference Manual.

Can I have an FTP, Mail or Web server and use NAT?

Yes, but you need to configure your router appropriately using the NAT Setting screen or the Command Line Interface (CLI). By entering a remote system or addServer command, you can add FTP, Mail, NetMeeting or Web servers to your LAN. These can then be accessed from another LAN or the Internet while NAT is enabled.

What is MER?

MER (MAC Encapsulated Routing) allows your router to perform routing on the LAN side and bridging on the WAN side. MER is needed only when your Network Service Provider doesn't support IP routing. MER adds NAT functionality, thereby providing greater security and more IP addresses for your LAN than what is provided by your NSP.

Why can't I get a response after entering a URL in my browser?

If you do not get a response, try pinging the IP address. If you get a response to pinging, then your Domain Name Service (DNS) is probably failing. You should contact your NSP for DNS assistance. If you do not get a response, then try pinging the WAN Gateway address (of your NSP) to confirm that your router can connect with the NSP.

If pinging fails, check the router's lights. The Link lights on the router front should be green. Also check your cable connections. If everything appears correct, check your IP configuration and ensure that the gateway and LAN IP addresses match.

How can I connect my modem for dial backup if the connector on my dialup modem doesn't match the console port on the router?

You need a special DB9 to DB25 connector, available from the Efficient Networks web site at the following address: http://www.efficient.com

My modem is not a V.90. Can I use it for dial backup?

Yes, you can use a non-V.90 modem with your router for dial backup. Be sure to use the correct initialization string for your modem (consult your modem documentation).
